RE: Review of the Regional Conformity Status for New and Revised Projects

Staff has prepared the following information in an effort to streamline the review of the regional air quality conformity implications of projects that staff proposes to add into the 2019 TIP through current or future revisions. This item is for advisory purposes only. The inclusion of these projects and project changes in a proposed revision to the TIP is subject to Commission approval in the case of amendments and MTC's Executive Director or Deputy Executive Director in the case of administrative modifications. The final determination of the regional air quality conformity status of these projects will be made by the Federal Highway Administration, the Federal Transit Administration and the Environmental Protection Agency as part of their review of proposed final TIP amendments and by the Executive Director or Deputy Executive Director as part of their review for TIP administrative modifications.

Changes Staff is Proposing to Include in the 2019 TIP

Staff is proposing to add 29 individually listed projects to the 2019 TIP. The description of the other new projects along with the regional air quality category that staff believes best describes the projects are included on Attachment A.

MTC staff is not seeking a determination on the status of these projects for project-level conformity purposes with this item.

- **1. Welcome and Self Introductions**: Harold Brazil (MTC) called the meeting to order at 9:35 am.
- 2. PM_{2.5} Project Conformity Interagency Consultations
 - a. Confirm Projects Are Exempt from PM_{2.5} Conformity
 - i. Projects Exempt Under 40 CFR 93.126 Not of Air Quality Concern

Task Force members had no comments.

Final Determination; With input from FTA, FHWA (via email), EPA, Caltrans and MTC, the Task Force agreed that the projects on the exempt list **2b_Exempt List 04092020.pdf** are exempt from PM_{2.5} project level analysis.

3. Transportation Air Quality Conformity Determination for the Amended Plan Bay Area 2040 (Plan) and the Amended 2019 Transportation Improvement Program (TIP)

Harold Brazil (MTC) stated that the amendment to Plan Bay Area 2040 (PBA2040) the Amended Plan and the 2019 Amended TIP regional conformity analysis was prepared in accordance with U.S. Environmental Protection Agency (EPA) conformity rules and MTC Resolution 3757. Mr. Brazil also noted that the close of the comment period was on April 24, 2020 and Adan Noelting (MTC) indicated the comments received to date included some opposition to the I-680 Express Lanes Gap Closure project, but the comments were similar in their levels of concern.

Ross McKeown (MTC) asked if the federal approval process for the I-680 Express Lanes Gap Closure project amendment could be expedited with the SAFE Rule part 2 becoming effective towards the end of June 2020 and Rodney Tavitas (Caltrans), Karina OConnor (EPA) and Dominique Kraft (FTA) all indicated that they would conduct their reviews rapidly.

4. Projects with Regional Air Quality Conformity Concerns

a. Review of the Regional Conformity Status for New and Revised Projects

Projects Staff Proposing to Include in the 2019 TIP

Adam Crenshaw (MTC) stated that MTC staff had received a request from sponsors to add three individually listed project and that one of the proposed new individually listed projects (US-101 Managed Lanes North of I-380, TIP ID: SM-190009) may be considered non-exempt from regional conformity. The Task Force had no comments on this item.

5. Consent Calendar

a. March 26, 2020 Air Quality Conformity Task Force Meeting Summary

Final Determination; The Task Force had no questions or comments on the summary from the March 26, 2020 Task Force meeting and the consent calendar was approved.

6. Other Items - SAFE Vehicles Rule for Model Years 2021-2026 Passenger Cars and Light Trucks

Key points discussed concerning the SAFE Rule Part 2 implementation included:

- The Commission is scheduled to approve the conformity analysis for the amended PBA2040 and the 2019 TIP at the end of May (May 27th) and Karina OConnor (EPA) indicated federal approval would not be held up by EPA.
- FTA and FHWA are both aware that MTC's conformity analysis needs to have expedited approval.
- Ms. OConnor felt federal approval on the conformity analysis should occur before June 30th.
- Ms. OConnor stated that EPA has had initial conversations with ARB about whether ARB is
 going to do any additional adjustment factors for EMFAC for SAFE Rule Part 2. Ms. OConnor
 went on to say that ARB is still looking at it, but it's EPA's sense that ARB may not be doing
 any additional adjustment factors for SAFE Rule Part 2 and EPA will keep working with ARB
 until a final decision is made.
- Ms. OConnor said that EPA assumes if ARB does do the adjustment factors, EPA would
 approve them quickly (corresponding to what happened before when the first set of EMFAC
 adjustment factors were approved for Part 1 of the SAFE Rule).
- Ms. OConnor also said that EPA's sense is ARB may not produce new factors because the impacts from SAFE Rule Part 2 will probably be smaller than what they were with Part 1 of the Rule.
- ARB could make their decision on whether to do new adjustment factors (or not) before June 30th.
- ARB was not in attendance for this meeting, but Harold Brazil (MTC) indicated that MTC will
 engage ARB to answer questions on this issue and attempt to have them in attendance at the next
 task force meeting on May 28th.

- Responding to Adam Noelting's question, Ms. OConnor indicated impacts on EMFAC from Part 2 of the SAFE Rule are less than the impacts from Part 1 (this is EPA headquarters understanding).
- Ms. OConnor stated no off-model adjustment factors will be produced by EPA for the rest of the country in MOVES 14b. The next version of MOVES will (potentially) contain effects from SAFE Rule Parts 1 and 2.
- Ross McKeown (MTC) asked if the conformity analysis SCAG has recently done for their new plan will meet their deadline and Ms. OConnor stated the federal agencies will be expediting their approval process for SCAG.
