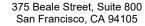

Contract Amendment – ActivitySim/emme Model Conversion Project: WSP USA, Inc. (\$200,000)

Subject:

A request for Committee approval of a contract amendment with WSP USA, Inc. in an amount not to exceed \$200,000, to continue to convert MTC's Travel Model Two (TM2) travel forecasting system to the ActivitySim and emme software platforms.

Background:

The MTC travel model forecasting system is used for a wide variety of requirements ranging from preparation of the Regional Transportation Plan and Sustainable Communities Strategy to detailed corridor studies. The travel models are an integral part of an integrated economic, land use and transport model system, including the use of REMI and Bay Area UrbanSim.

In September of 2020, following a competitive procurement process and approval from this Committee, MTC retained WSP USA, Inc. for the conversion of TM2 to the ActivitySim and emme software platforms for a period of performance through June 30, 2023. This contract was amended July 1, 2021 to add an additional \$150,000, increasing the not to exceed amount to \$500,000.

TM2 currently utilizes two primary software packages – CT-RAMP (Java based software) and Cube Voyager (transport network software). MTC is one of the original founders of a consortium of public agencies¹ under the AMPO banner, to develop and enhance the ActivitySim platform. ActivitySim is now available to replace CT-RAMP. ActivitySim offers a more sustainable and useable software platform to support TM2.

The emme software platform provides MTC with the full range of capabilities needed to adequately support both the current version and expected enhancements to TM2, including the ability to consider transit capacity, crowding, and reliability. The Cube Voyager software is

unable to provide this capability. As such, the use of emme provides MTC with a significantly

more advanced transport modeling software platform.

This project will migrate the complete TM2 model system, i.e., the supply and demand

components and supporting software/scripts, to the ActivitySim and emme platforms.

MTC anticipates that many, if not most, of our regional partners (County Transportation

Agencies ("CTAs") and transit service providers) will embrace TM2 as their modeling platform

in which to perform their respective planning and operational responsibilities.

The purpose of this requested amendment is to improve the representation of the transit network

with the removal of transit access points that will, in turn, reduce the model application run time.

The consultant's and their subcontractors' small business and disadvantaged enterprise status is

Subject:

Request for approval of contract amendment with Craft & Commerce, LLC in the amount of \$220,000 for digital communications and promotions support of the regional Bike to Work Day program, as well as ongoing, as-needed digital engagement and promotion services for fiscal year 2022-23.

Background:

In December 2021, the MTC Administration Committee approved the 2021 Public Engagement, Digital Engagement and Promotion, and Market Research Support Consultant Bench ("the Bench"), comprised of 13 pre-qualified firms. The 2021 Bench procurement contained three service categories:

- A. Public engagement
- B. Digital engagement and promotion
- C. Market research

In addition to establishing the Bench, the request for qualifications also requested proposals from consultants for a direct select contract under Service Category B: Digital Engagement and Promotion to continue MTC's digital engagement and promotion activities, including the development and implementation of the ongoing All Aboard Bay Area Transit campaign. In December 2021, the MTC Administration Committee approved a three-year contract with Craft & Commerce, LLC for this work. The committee approved the contract in an amount not to exceed \$175,000 for the initial work on the All Aboard campaign and other digital engagement tasks.

In February 2022, the Executive Director approved a contract amendment to increase the budget by \$200,000 for a new not to exceed total contract amount of \$375,000 to create and launch the second phase of the All Aboard Bay Area Transit campaign and provide digital engagement support for BAIFA-related projects. The All Aboard Bay Area Transit campaign, created at the

behest of the Blue Ribbon Transit Recovery Task Force and in concert with the Bay Area's 27

transit agencies, aims to encourage the public to return to Bay Area transit. The first phase of the

campaign, created in mid-2021, ran in late summer 2021. The second phase is scheduled to run

in May and June 2022.

Contract Amendment for Ongoing Work

The proposed contract amendment would fund digital communications and promotions support

for the regional Bike to Work Day program, as well as ongoing, as-needed digital engagement

and promotion services for the agencies for fiscal year 2022-23. This amendment would add

\$220,000, bringing the contract to a new total not to exceed \$595,000. Of the amended amount,

\$35,000 is available in the FY 2021-22 MTC budget. The remaining \$185,000 would be subject

to approval of the MTC FY 2022-23 budget. Neither Craft & Commerce, LLC nor its

subcontractors are small or disadvantaged business enterprises.

In December 2020, the MTC Administration Committee approved the 2020 Website Support Services Bench Cycle 1 ("the Bench"), comprised of 20 pre-qualified firms. The 2020 Bench procurement contained two service categories, i.e., areas of expertise: 1) Website Operations and Maintenance Services; and 2) Website Design, Development, and Enhancement Services. Award of a contract with one of the pre-qualified consultants may take place by direct selection or via mini-procurement, pursuant to MTC's procurement procedures.

In February 2021, MTC selected Peak Digital, LLC from the pre-qualified firms to provide website support services to operate, maintain, and enhance MTC and Association of Bay Area Government (ABAG)-related agency websites through June 30, 2024.

In June 2021, the MTC Administration Committee approved a contract amendment to provide ongoing website support services to operate, maintain, and enhance agency websites. In August 2021, and in December 2021, the Executive Director approved contract amendments with Peak Digital, LLC to provide website support services for the BayREN website and for the Technical Assistance web portal. In February 2022, the MTC Administration Committee approved a contract amendment to provide a managed services solution for the hosting of the agency websites.

This amendment would allow Peak Digital, LLC to provide ongoing website support services to operate, maintain, host, and enhance agency websites for FY 2022-23. In addition, Peak Digital, LLC provides technical support for compliance to Section 508 of the Federal Rehabilitation Act, which is essential to ensure that agency websites meet the accessibility standards set forth by Section 508. In addition, Peak Digital, LLC provides technical support for Brown Act compliance. Continued technical support for the abovementioned federal and state requirements

This amendment would add \$840,000 for FY 2022-23, bringing the contract to a new total not to

Background:

Since 2014, MTC has utilized the Socrata Open Data Platform (SODP) to host and share data for several key agency initiatives, including VitalSigns and Plan Bay Area 2050. The Socrata SODP service remains a key part of the Bay Area Spatial Information System Initiative (BASIS). It is anticipated that the use of Socrata will expand as the agency expands the use of data to inform policies and programs.

MTC currently purchases a Socrata license from Carahsoft through a sole source PO in the amount of \$180,000. The PO covered the licensing agreement from July 1, 2021 to April 30, 2022. The additional time and funding requested for this PO amendment will pay for licensing Socrata Connected Government Cloud (Socrata) services from Carahsoft for the period of May 1, 2022 through June 30, 2022.

Carahsoft is neither a small business nor a disadvantaged business enterprise and has no subcontractors.

Issues:

Switching to a different "Data as a Service Platform" would negatively impact the continued support of VitalSigns, BASIS and other work currently underway within the agency, as well as divert significant staff resources to make the switch. Staff believe that Carahsoft provides a high-quality product at a competitive price.

Contract Amendment – BAHFA Business Plan: Forsyth Street Advisors LLC (\$500,000)

Subject:

Staff requests the Committee's approval to amend the contract with Forsyth Street Advisors LLC in an amount not to exceed \$500,000 for the Bay Area Housing Finance Authority (BAHFA) Business Plan Project (Project), and extend the period of performance through December 31, 2023.

Background:

Following a procurement process that commenced in February 2021, in July 2021 the Administration Committee approved the selection of the BAHFA Business Plan consultant team comprised of Forsyth Street Advisors LLC (lead entity), Bonnewit Development Services, the Othering and Belonging Institute (UC Berkeley), the Terner Center for Housing Innovation, Sperry Capital, CFX (a consultant to public financing authorities nationally), Strategic Economics, Ernst & Young, Orrick, Herrington & Sutcliffe, and Renne Public Law Group (Business Plan Team; Team). The Team is multidisciplinary and highly experienced in affordable housing financing, production, and preservation, as well as the program approaches that will best create equity and racial justice in under-represented communities.

The Business Plan Team kicked off its work in earnest in early 2022 and expects to produce a Draft Equity Framework and draft presentation of Funding Program Concepts to the ABAG Housing and BAHFA Oversight Committees by the end of 2022. As part of the initial phase of work, staff reevaluated the contract pricing and confirmed the need to provide additional resources for the business planning process for the Team to conduct more extensive regional stakeholder engagement and also analyze potential near-term financing opportunities arising through unanticipated and potential state and federal funding availability. Relatedly, the updated project plan now anticipates completion of the Business Plan by December 31, 2023 – ten months beyond the initially anticipated completion date. Staff recommends increasing the contract value by \$500,000, for a total not to exceed amount of \$1,000,000 and extending the period of performance through December 31, 2023, accordingly.

Funding for the contract amendment comes from the \$20 million state grant to support the launch of BAHFA. The requisite funds have been set aside for this purpose during the adoption

of the inaugural BAHFA budget by the BAHFA Board on April 27, 2022. Since the original contract was executed by MTC, MTC will execute the amendment, subject to BAHFA approving payment of the invoices.

The consultants and their subcontractors' small business and disadvantaged enterprise status is shown in Attachment A.
