Please be advised that MTC recently made several changes to the 2023 Federal Transportation Improvement Program (TIP). TIP Revision No. 2023-03 revises four

Federal D. Glover projects with a net increase in funding of \$26.2 million across all program years. Among other changes, this revision:

- Updates the funding plans of San Francisco's Folsom Streetscape project and • Yerba Buena Island Ramp Improvements project to reflect the awards of Federal Earmarks: and
- Updates the funding plan of the Treasure Island Mobility Management Agency • project to reflect changes in schedule and the programming of Affordable Housing Sustainable Communities (AHSC) funds.

The Administrative modification is financially constrained by year and MTC relies on the State's programming capacity in the amount of \$9.2 million in RIP funds, \$475,000 in repurposed earmark funds, \$750,000 in AHSC funds, \$18 million in RAISE funds, \$390,000 in TFCA funds, and \$3 million in Ferry Boat Discretionary (FBD) funds.

The investments described in MTC's 2023 TIP, as revised with TIP Revision No. 2023-03, make progress toward achieving the performance targets set by the region in accordance with the applicable provisions and requirements of 23 CFR Part 450.

The projects that are included in this administrative modification are not included in any other amendment that is open for public review. MTC's 2023 TIP, including the proposed Revision No. 2023-03, is consistent with metropolitan transportation planning regulations per 23 Code of Federal Regulations Part 450 and conforms to MTC's Andrew B. Fremier Regional Transportation Plan.
