Contract – BART Transit Passenger Survey: ETC Institute (\$900,000); and Caltrain Transit Passenger Survey: Resource Systems Group, Inc. (\$300,000)

Subject:

Request to authorize the Executive Director to negotiate and enter into: 1) a contract with ETC Institute for an amount not to exceed \$900,000 to survey BART transit passengers, and 2) a contract with Resource Systems Group, Inc. (RSG) for an amount not to exceed \$300,000 to survey Caltrain transit passengers. These surveys are conducted as part of the 2023 Transit Passenger Surveying Services Bench ("Project").

Background:

MTC collects travel behavior and demographic data for the region's transit passengers to serve two agency needs. The first is to assist with Title VI of the 1964 Civil Rights Act compliance for regional expenditures and to facilitate various transit rider equity analyses. The second goal is to collect passenger travel pattern data for the refinement of MTC and partner agencies' analytical planning tools, including regional and county-level travel demand models.

As part of regional Resolution 3866, the Transit Coordination Implementation Plan, MTC collects transit passenger demographic and travel pattern information in cooperation with transit agencies. Given the size of the regional transit fleet, such data collection takes five years to complete a full cycle of all Bay Area Transportation Development Act-claiming operators, surveying a few operators every spring and every fall. This program was suspended during the Covid pandemic and is now resuming its cadence, starting with the BART and Caltrain surveys. Post-pandemic, MTC is attempting to keep the sequence of operators surveyed in the same order as data had been collected prior to 2020.

Procurement:

MTC issued a Request for Qualifications (RFQ) on June 29, 2023, to procure a bench of consultants or consultant teams to conduct the Project. Required services shall be authorized by Contract or Purchase Order and will be based on the Preliminary Scope of Work included in the RFQ. The RFQ allowed for services through June 30, 2028, with the option to renew through

2030. In September 2023, the Administration Committee approved a pre-qualified consultant panel of the following three firms: Corey, Canapary & Galanis; ETC Institute; and RSG.

Bench consultants for the BART and Caltrain surveys were chosen via a direct select process. For each survey, the three pre-qualified consultants were provided a detailed statement of project goals. They were then asked to prepare a 5–7-page written response that described their project approach and methodology and were also invited to participate in a one-hour interview to present their proposal and respond to questions. ETC Institute was selected for the BART survey based on their project team and approach, and RSG was selected to administer the Caltrain survey.

Attachment A includes a list of ETC Institute and RSG and their subcontractors Small Business Enterprise (SBE) and Disadvantaged Business Enterprise (DBE) status.

Issues:

None identified.

Recommendations:

Staff recommends that the Committee authorize the Executive Director or his designee to negotiate and enter into a contract in an amount not to exceed \$900,000 with ETC Institute for a survey of BART passengers and to negotiate and enter into a contract in an amount not to exceed \$300,000 with RSG for a survey of Caltrain passengers.
