Notes:

- Action # refers to the twenty-seven actions in the Transit Transformation Action Plan. Actions 26 and 27, related to Funding, are not included in this Blue Ribbon Program of Projects. Additional alphabetical identifiers have been added to identify projects related to the initiative and action. "X" signifies a funding exchange.
- Population-based STA is programmed to the Blue Ribbon Program through MTC Res. No. 4450, FY 2022-23 Fund Estimate. STA Revenue-based STA Exchange funds are programmed through MTC Res. No. 4529.
- The Bay Bridge Forward project, 9a, will receive OBAG 2 funds from the RTC project (Action 25a) and the RTC Project will be allocated \$500,000 in Blue Ribbon funds.
- Clipper BayPass Phase 1 programming covers the initial two years of the program (August 2022 to August 2024).
- These funds will support staff work related to Fare Coordination/Integration Study implementation, Mapping and Wayfinding project development, Transit Priority coordination, overall implementation of the Action Plan, and Transit 2050+ (connected network planning).
- BART's total Phase 1 (August 2022 to August 2024) Clipper BayPass reimbursement allocation totals \$4,332,098. Of this total, \$2,331,423 is STA Population-Based funds programmed through MTC Resolution 4519 (Blue Ribbon Transit Transformation Action Plan Program of Projects) while the remaining \$2,000,675 is to be fulfilled with FY 2024-25 STA Population-Based Regional Program funds programmed to Clipper BayPass via MTC Resolution 4642 and allocated via Programming and Allocations Committee action in September 2024.
