RE: Review of the Regional Conformity Status for New Projects

Staff has prepared the following information in an effort to streamline the review of the regional air quality conformity implications of projects that staff proposes to add into the 2019 TIP through current or future revisions. This item is for advisory purposes only. The inclusion of these projects and project changes in a proposed revision to the TIP is subject to Commission approval in the case of amendments and MTC's Executive Director or Deputy Executive Director in the case of administrative modifications. The final determination of the regional air quality conformity status of these projects will be made by the Federal Highway Administration, the Federal Transit Administration and the Environmental Protection Agency as part of their review of proposed final TIP amendments and by the Executive Director or Deputy Executive Director as part of their review for TIP administrative modifications.

Projects Staff is Proposing to Include in the 2019 TIP

Staff has received requests from sponsors to add two new individually listed projects and 38 new grouped listed projects to the 2019 TIP. Attachment A includes a list of the remaining projects along with the regional air quality category that staff believes best describes the projects.

MTC staff is not seeking a determination on the status of these projects for project-level conformity purposes with this item.

- 1. Welcome and Self Introductions: Harold Brazil (MTC) called the meeting to order at 9:35 am.
- 2. PM_{2.5} Project Conformity Interagency Consultations
 - a. Confirm Projects Are Exempt from PM_{2.5} Conformity
 - i. Projects Exempt Under 40 CFR 93.126 Not of Air Quality Concern

Harold Brazil (MTC) asked if Task Force members had questions on the **2b_Exempt List 112018.pdf** exempt under 40 CFR 93.126, list of projects and Ginger Vagenas (EPA) noted <u>TIP ID</u> # <u>ALA190004</u> – the Alameda Regional Access Phase II project – included many components, one of which being traffic signal modifications at the Fifth Street and Constitution Way intersection. Ms. Vagenas asked for additional information on the traffic signal modifications and Adam Crenshaw (MTC) stated he would follow-up with the project sponsor and provide the information to the Task Force.

Dick Fahey (Caltrans) asked why the "Hazard elimination program" project type code exempt under 40 CFR 93.126 was used for *TIP ID # ALA170043* – the 14th Street Safe Routes in the City project – instead of the standard "Bicycle and pedestrian facilities" project type code? Adam Crenshaw (MTC) indicated the "Hazard elimination program" exempt code was used due to the road diet component of the project and Mr. Fahey agreed that using that exempt code was reasonable. Dominique Kraft (FTA) asked more information about the "Accelerated Bridge" component of the Macarthur Maze/Increase Vertical Clearance project (*TIP ID # ALA190003*) and Mr. Crenshaw, Ms. Vagenas, Mr. Fahey and Panah Stauffer (EPA) indicated that term has do with the fund programming process speed being "Accelerated".

Ms. Vagenas asked if projects listed in Mr. Crenshaw's regional memo list of projects eventually migrate to the projects exempt under 40 CFR 93.126 list and also asked why the projects would be listed twice. Mr. Crenshaw indicated that if a project previously had not be listed on the exempt under 40 CFR 93.126 list, they would need to be on the list for review by the Task Force before the project is able to complete its environmental process. Mr. Crenshaw went on to say the projects included in the regional list of projects are new projects being added to TIP (ahead of the project conducting its environmental process) so that the Task Force can ask questions or address any potential issues with the project for regional conformity.

Final Determination: With email follow-up input from FHWA – FTA, EPA, Caltrans and MTC, the Task Force agreed that the projects on the exempt list (**2b_Exempt List 112018.pdf** – not including <u>TIP ID # ALA190004</u> pending the traffic signal modification information from the project sponsor – are exempt from PM_{2.5} project level analysis.

3. Projects with Regional Air Quality Conformity Concerns

a. Review of the Regional Conformity Status for New and Revised Projects

Projects Staff Proposing to Include in the 2019 TIP

Adam Crenshaw (MTC) stated that MTC staff had received requests from sponsors to add eight new individually listed projects and 26 new grouped listed projects to the 2019 TIP. Mr. Crenshaw specifically discussed the Oakley Station Platform project (FMS ID: 6953) which is already included in the Amended Plan Bay Area 2040 but is being added to the 2019 TIP because the project sponsor is now able to move forward with the federally funded portions of the project. Mr. Crenshaw added that The Oakley Station Platform project includes the construction of a new fixed-guideway station that may not currently be treated as exempt from regional-level conformity under 40 CFR 93.126 or 40 CFR 93.127 – however, this project is included as a standalone project in the Amended Plan Bay Area 2040 and was included in the 2030 air quality conformity analysis year in the Air Quality Conformity Analysis for the Amended Plan Bay Area 2040 and the 2019 TIP. Ginger Vagenas (EPA) asked for clarification on which TIP the Oakley Station Platform project was being added to and Mr. Crenshaw indicated that the project is being added to the 2019 TIP, although the project was included in the most recent 2019 TIP/Amended Plan Bay Area 2040 conformity analysis. The Task Force had no further comments.

4. Consent Calendar

b. December 6, 2018 Air Quality Conformity Task Force Meeting Summary

Final Determination: With input from all members, the Task Force concluded that the consent calendar was approved.

5. Other Items - Updates

a. OTAQ's South Coast II Transportation Conformity Guidance

Harold Brazil (MTC) noted the posting of OTAQ's finalized guidance to address how transportation conformity can be implemented in ozone nonattainment and maintenance areas affected by the February 16, 2018 decision from the U.S. Court of Appeals for the D.C. Circuit in South Coast v. EPA {"South Coast II," 882 F.3d 1138}.
